Resolution 14-15

A Resolution Establishing a Question to be on the 2014 General Election Ballot

WHEREAS, the Browns Valley City Council has investigated the facts and does hereby find, determine, and declare that with the sale of the Browns Valley Liquor Store it is necessary and expedient to allow establishments that qualify under M.S.A. §340A.504, Subd. 3(a) to sell intoxicating liquor for consumption on the premises ("on-sale") in conjunction with the sale of food between the hours of 10:00 a.m. on Sundays and 2:00 a.m. on Mondays;

WHEREAS, the Browns Valley City Council has the authority to direct that a question be placed on the ballots to be used by the electorate in the City of Browns Valley;

WHEREAS, the Browns Valley City Council desires to exercise said authority to poll the electorate pertaining as to whether statutorily eligible establishments may be allowed to sell intoxicating liquor for consumption on the premises in conjunction with the sale of food between the hours of 10:00 a.m. on Sundays and 2:00 a.m. on Mondays; and

WHEREAS, the proposition of authorizing the issuance of on-sale licenses to statutorily eligible establishments for the sale of intoxicating liquor in conjunction with the sale of food between the hours of 10:00 a.m. on Sundays and 2:00 a.m. on Mondays shall be submitted to the qualified electors of the City of Browns Valley at the general election to be held on November 4, 2014.

NOW, THEREFORE BE IT RESOLVED, that the Browns Valley City Council directs the Traverse County Auditor-Treasurer to take the necessary steps to place the following question on the ballot to be used in the November 2014 general election:

AUTHORIZING THE ISSUANCE OF ON-SALE LICENSES FOR THE SALE OF INTOXICATING LIQUOR ON SUNDAYS IN THE CITY OF BROWNS VALLEY

The Browns Valley City Council has authorized a referendum for the purpose of determining whether the citizens of the City of Browns Valley desire the Browns Valley City Council to issue on-sale licenses to statutorily eligible establishments for the sale of intoxicating liquor on Sundays.
